



What we found - key findings

System Fragmentation

Lack of national framework leads to inconsistent rules and unclear roles.

Sector Divisions

Conflicts between conservation and welfare stakeholders hinder collaboration.

Informal Labour Reliance

Over-dependence on volunteers without adequate support.

Data Deficiencies

Lack of standardized data hinders effective decisionmaking.

Unity Opportunities

Shared commitment and potential for collaboration.



Legal Grey Areas

Outdated laws and ambiguous definitions create confusion and risk.

Urban-Rural Disparities

Differences in resources and attitudes between urban and rural areas.

Desexing and Containment

Strong consensus on neutering and containment as solutions.


Legal Reform Needs

Calls for updated laws and strategic coordination.



The Big Picture

- **Two goals:** protect wildlife AND improve cat welfare.
- No national framework: fragmented rules across states and councils.
- **Result:** confusion, inefficiency, mistrust.





Public Attitudes

- Views shaped by headlines, not daily life.
- Contradictions: feed cats but oppose neutering.
- **Signs of change:** empathy rising, more adoptions, support for containment.





What Divides the System

- Conservation vs. welfare priorities.
- TNR: illegal but practiced.
- Urban vs. rural vs. Indigenous differences.





What Unites the System

- Agreement on desexing.
- Containment supported if helpful not punitive.
- Shared frustration with fragmentation.
- Sense that 'we can do better.'





Pressures on the System

- Volunteers and carers overstretched.
- Veterinary services limited.
- Patchy, inconsistent data.





Pathways Forward

- Track A: prevention, containment, adoption, managed transitional programmes.
- Track B: biodiversity-sensitive areas, fit-for-place tools, visible safeguards.
- **Equity matters:** co-designed services, renter-friendly support, visiting-vet models.





Moving Forward

- Language matters: avoid 'war on cats'.
- Monitoring: milestones (did we do it?) and indicators (is it working?).
- Shared commitment to humane, evidence-based, coordinated solutions.

- 3. Facilitate humane, pragmatic, and inclusive population management solutions
